## PRODUCTION SPECIFICATIONS

Aloha Visitor Guides will be produced using up-to-the-minute publishing technology. All files submitted not conforming to our specifications will require production time and will incur additional production charges.

## ACCEPTED FILE FORMATS

Hi-resolution PDF files with embedded fonts and images (300dpi in cmyk) is preferred. Macintosh-formatted digital files in QuarkXPress, Adobe InDesign, Adobe Photoshop and Adobe Illustrator accepted however additional charges may be necessary to make press ready. Color Images: Save in CMYK color mode as TIFF. Black and White Images: Bitmap or Grayscale TIFF. Image Resolution: CMYK and Grayscale 300dpi at 100% of size. Bitmap images 800dpi at 100%.

## FILE SETUP

Document Size: (See Mechanical Requirements). Bleed ads: The document size should match the trim size. Extend items that will bleed 1/8" beyond the page edges into the pasteboard area. For a full bleed, extend all four sides. Live Matter Area: Keep all text 1/4" inside the trim to ensure that text does not get cut off. Correct Color Palette Settings: Convert all RGB colors to CMYK. Convert all spot colors, including Pantone, to CMYK.

## COLOR PROOFS

Please provide a press-calibrated color proof with your files. We cannot be responsible for printed results if a proof is not provided. If color accuracy is important to you, a calibrated contract color proof can be purchased at an additional charge prior to material deadline. Please ask for more info.

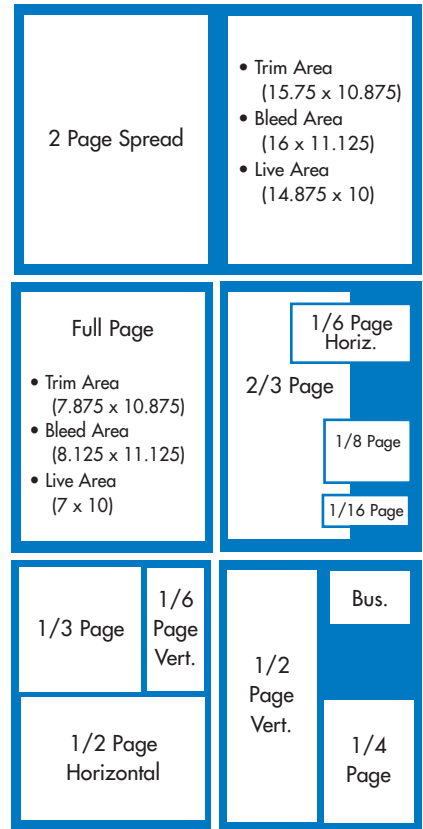
